The allowable expense with the scholarship funds is for the cost of tuition only (\$1,850 per applicant).

If your application is approved, POST will provide you with a Scholarship Reimbursement Form with your executed Purchase Order. The reimbursement form will need to submitted once the class has been completed with the required documentation (certificate of completion and proof of payment).
